In recognition of his service, he has been honored by the Connecticut Bar Association with the Citizen of the Law Award in 2025 and the Honorable Anthony V. Garza is a member of the Connecticut Bar Association, the President-Elect of the Connecticut Hispanic Bar Association, and a member of the Northeast Energy and Commerce Association. He is also the Secretary of the board of directors at the Chrysalis Center.
