## Chambers High Net Worth Recognizes Day Pitney and 16 Attorneys for Private Wealth Law

The firm was again ranked in the *Chambers HNW Guide for Private Wealth Law* in the Nationwide Eastern Region, as well as in Connecticut, Massachusetts, New Jersey and New York. Day Pitney is one of only two law firms to receive Band 1 rankings in Connecticut, and is tied for the most attorneys ranked in the state. The firm also received a Band 1 ranking in Massachusetts, and is tied for both the most Band 1-ranked attorneys and the most attorneys ranked overall in the state.
